

Privacy Policy

INTRODUCTION

RAPAC respects your privacy. This policy describes the types of information we may collect from you or that you may provide when you visit the website rapac.com (our "Website") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

- On this Website.
- In email, text, and other electronic messages between you and this Website.
- When you interact with our advertising and applications on third-party websites and services if those applications or advertising include links to this policy.

It does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by RAPAC or any third party (including our affiliates and subsidiaries); or
- Any third party, including through any application or content (including advertising) that may link to or be accessible from or on the Website.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Website. By accessing or using this Website, you agree to this privacy policy. This policy may change from time to time. Your continued use of this Website after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

LINKS TO OTHER SITES.

RAPAC may provide links to third parties' sites that otherwise may be of interest to you or provide you with information regarding our

products. RAPAC's Privacy Policy does not control how such third parties define personal data or how they use it. We encourage you to read their privacy policies and know your privacy rights before interacting with them. RAPAC shall not be responsible for the protection and privacy of any information that you disclose or may be gathered by such third parties when you visit such sites.

WHAT IS PERSONAL DATA AT RAPAC?

RAPAC treats data relating to an identified or identifiable individual as "personal data".

YOUR PRIVACY RIGHTS AT RAPAC

At RAPAC, we respect your ability to know, access, correct, transfer, restrict the processing of, and delete your personal data. You are entitled to request access to and correction of all your personal data collected by us via this Website, as well as to require us to delete your data if you no longer want us to process it. You can make such a request or a related inquiry by emailing us at privacy@ringcontainer.com. You can find out more details by emailing us as provided above. RAPAC does not sell your data including as "sale" is defined in Nevada and California. Please note that there will be situations where we cannot grant your request to delete personal data.

PERSONAL DATA RAPAC COLLECTS FROM YOU

At RAPAC, we strive to collect only the personal data that we need. The personal data collected by RAPAC depends on how you interact with RAPAC. We may collect a variety of information, including:

- **Account Information.** Account details and prior order and shipment history.
- **Device Information.** Data from which your computing device could be identified, such as browser type and version, operating system and interface, your Internet connection, and the email address or website from which you are visiting.
- **Contact Information.** Data such as name, email address, physical address, phone number, or other contact information.
- **Payment Information.** Data about your billing address and payment related information.

- **Transaction Information.** Data about purchases of RAPAC products and services or transactions facilitated by RAPAC.
- **Fraud Prevention Information.** Data used to help identify and prevent fraud.
- **Usage Data.** Data about your activity on and use of our websites or portals, including browsing history, search history, product interaction, diagnostic data, and other usage data.
- **Financial Information.** Details relating to business transactions undertaken with RAPAC.
- **Government ID Data.** We may ask for government-issued identification numbers in limited circumstances, including when setting up an account and for the purpose of extending commercial credit, or as required by law.
- **Other Information You Provide to Us.** Details such as the content of your communications with RAPAC, including interactions with customer support and contacts through social media channels.

You are not required to provide the personal data that we have requested. However, if you choose not to do so, we will not be able to provide you with our products or respond to requests you may have.

PERSONAL DATA RAPAC RECEIVES FROM OTHER SOURCES

RAPAC may receive personal data about you from third parties. RAPAC uses such personal data to process your transactions, to communicate with you, for security and fraud prevention, and to comply with law. We may also use personal data for other purposes with your consent. Sources of such information include:

- **Individuals.** RAPAC may collect data about you from other individuals.
- **At Your Direction.** You may direct other individuals or third parties to share data with RAPAC.
- **RAPAC's Business Partners or Vendors.** We may also validate the information that you provide such as obtaining information from third parties for security and fraud prevention purposes.

RAPAC'S USE OF PERSONAL DATA

RAPAC uses your personal data only when we have a valid legal basis to do so. Depending on the circumstances, RAPAC may rely on your consent or the fact that the processing is necessary to fulfill a contract with you, protect your interests or those of other persons, or to comply with law. We may also process your personal data where we believe it is in our or others' legitimate interests.

- **Internal purposes.** RAPAC collects personal data necessary to personalize or improve our offerings, for internal purposes such as auditing or data analysis, or for troubleshooting.
- **Process Your Transactions.** To process transactions, RAPAC must collect data such as your name, purchase, and payment information. To carry out our obligations and enforce our rights arising from any contracts entered between you and us, including for billing and collection.
- **Communicate with You.** To respond to communications, reach out to you about your transactions or account, market our products and services, provide other relevant information, or request information or feedback. From time to time, we may use your personal data to send important notices, such as communications about purchases and changes to our terms, conditions, and policies. Because this information is important to your interaction with RAPAC, you may not opt out of receiving these important notices.
- **Security and Fraud Prevention.** To protect against loss prevention and to prevent fraud.
- **Comply with Law.** To comply with applicable law such as satisfying tax or reporting obligations, or to comply with a lawful governmental request.

RAPAC retains personal data for so long as necessary to fulfill the purposes for which it was collected. When assessing retention periods, we will examine whether it is necessary to retain the personal data collected.

RAPAC'S SHARING OF PERSONAL DATA

RAPAC may share personal data with service providers who act on our behalf, our business partners, or others at your direction. Further, RAPAC

does not share personal data with third parties for their own marketing purposes.

- **Service Providers.** RAPAC may engage third parties to act as our service providers and perform certain tasks on our behalf, such as delivering products to customers.
- **Business Partners.** At times, RAPAC may partner with third parties to provide goods or services.
- **Others.** RAPAC may share personal data with others at your direction or with your consent. We may also disclose information about you if we determine disclosure is necessary or appropriate for purposes of national security, law enforcement, or other issues of public importance. Also, RAPAC may also disclose information about you if we determine that disclosure is reasonably necessary for any legitimate business purpose including to enforce our terms and conditions of any contract with you or to protect our operations, or in the event of a reorganization, merger, or sale.

PROTECTION OF PERSONAL DATA AT RAPAC

RAPAC employs reasonable measures to maintain all personal data provided by you or others on computer servers in a controlled and secured environment to hinder unauthorized access, loss, alteration, use or disclosure of such information. However, the nature of the Internet is such that information may be transmitted over networks without appropriate security measures and may be accessed, deleted, altered, used, or disclosed by unauthorized persons.

COOKIES AND OTHER TECHNOLOGIES

RAPAC's websites, online services, interactive applications, email messages, and advertisements may use "cookies" and other technologies to help us to better understand user behavior including for security and fraud prevention purposes, tell us which parts of our websites people have visited, and facilitate and measure the effectiveness of advertisements and web searches.

- **Communications Cookies.** These cookies are used to enable network traffic to and from RAPAC's systems, including by helping us detect any errors.

- **Strictly Necessary Cookies.** These cookies are set as required to provide a specific feature or service that you have accessed or requested.
- **Other Cookies.** These cookies are used to understand how visitors interact with our websites and online services, including by helping us to assess the effectiveness of advertisements and web searches. RAPAC also uses these cookies to remember choices you make while browsing, so we can provide you with a customized experience. If you prefer that RAPAC not use cookies, we provide you with the means to disable their use. Certain features of the RAPAC website may not be available if all cookies are disabled.

In addition to cookies, RAPAC uses other technologies that help us achieve similar objectives. In some email messages RAPAC sends to you, we provide a “click-through URL” that links you to content on the RAPAC website. We may track this click-through to help us determine interest in particular topics and measure whether we are communicating with you effectively. If you prefer not to be tracked in this way, you should not click graphic or text links in email messages.

Pixel tags enable us to send email messages in a format that you can read, and they tell us whether mail has been opened. We may use this data to reduce or eliminate messages sent to customers.

RAPAC generally treats data we collect using these cookies and similar technologies as nonpersonal data. However, to the extent that Internet Protocol (IP) addresses or similar identifiers are considered personal data by local law, we also may treat these identifiers as personal data.

TRANSFER OF PERSONAL DATA BETWEEN COUNTRIES

Your personal data may be transferred to or accessed by entities around the world. RAPAC complies with laws on the transfer of personal data between countries to help ensure your data is protected, wherever it may be. The RAPAC entity that controls your personal data may differ depending on where you live.

OUR COMPANYWIDE COMMITMENT TO YOUR PRIVACY

To make sure your personal data is secure, we communicate our privacy and security guidelines to RAPAC employees and strictly enforce privacy safeguards within the company.
